## 1. INTRODUCTION

The Board of the Royal Australasian College of Physicians has established the Adult Medicine Division Council (the "Council"). The <u>Governance of College Bodies By-law</u> sets out the general provisions for governance of Board Committees. Both the Governance of College Bodies By-law and this By-law govern the Council.

#### 2. PURPOSE

The purpose of this Council is to be the College's peak body representing the interests of Fellows and trainees of the Adult Medicine Division.

## 3. FUNCTIONS

The functions of the Adult Medicine Division Council include:

- a) supporting the professional careers of Fellows and trainees of the Adult Medicine Division;
- b) working with appropriate College bodies and staff in relation to:
  - i. education, training and assessment of trainees;
  - ii. training and continuing professional development;
  - iii. policy and advocacy; and
  - iv. the assessment of overseas trained professionals, as each relates to the Adult Medicine Division;
- c) promoting and advancing the body of knowledge of Adult Medicine;
- acting as an authoritative source of advice within the College in connection with Adult Medicine; and
- e) providing governance and oversight for other Adult Medicine bodies of the College, including:
  - i. the Adult Medicine Division Education Committee;
  - ii. the Australasian Chapter of Addiction Medicine;
  - iii. the Australasian Chapter of Palliative Medicine; and
  - iv. the Australasian Chapter of Sexual Health Medicine.

## 4. COMMITTEE PROHIBITIONS

The Council must not:

- Enter into any agreement binding upon it or on the College; or
- Represent or imply in any way that the Council is a body independent of the College.

## 5. MEMBER COMPOSITION

The membership of the Council shall comprise up to 41 members, comprising:

#### 5.1. Ex-officio Members

Up to eight ex-officio members:

- the Chair, Aotearoa New Zealand Adult Medicine Division Committee
- the Chair, Adult Medicine Division Education Committee
- the Adult Medicine Division Continuing Professional Development Lead
- the President, President-elect, or an appointed office holder of the Australasian Chapter of Addiction Medicine
- the President, President-elect, or an appointed office holder of the Australasian Chapter of Palliative Medicine
- the President, President-elect, or an appointed office holder of the Australasian Chapter of Sexual Health Medicine
- an Adult Medicine Division Fellow representative of the Adolescent and Young Adult Medicine Committee
- Chair, College Trainees' Committee (if an Adult Medicine Division trainee) or delegate who must be an Adult Medicine Division trainee.

## 5.2. Appointed Members

Up to 26 appointed members:

- up to three Adult Medicine Division trainee representatives (to include at least one Basic Trainee and one Advanced Trainee)
- one representative of each Specialty Society affiliated with the Adult Medicine Division (refer to Schedule 1). The Specialty Society representative must be:
  - a Fellow of the College; and
  - the President, President-elect or Vice President of the relevant Specialty Society or any other officeholder of the relevant Specialty Society approved by the Specialty Society President.

## 5.3. Elected Members

Up to seven elected members, elected by the Members of the Division:

- the President of the Division (to Chair)
- the President-elect of the Division
- four Australian Fellows of the Division elected by Members of the Division resident in Australia
- one Aotearoa New Zealand Fellow of the Division elected by Members of the Division resident in Aotearoa New Zealand.

## 5.4. Co-opted members

Co-opted members may be appointed for a particular purpose or term.

## 6. EXECUTIVE COMMITTEE

## 6.1. Establishment of the Executive Committee

Subject to Board approval, the Council may, if it considers it necessary to do so, establish an Executive Committee.

## 6.2. Role of the Executive Committee

The Executive Committee shall meet in the intervening periods between Council meetings and as otherwise required by the Council, to exercise such powers of the Council in managing the business and the interests of the Division, as may be delegated to it by resolution of the Council, or as the President, in cases of emergency, may decide.

## 6.3. Membership of the Executive Committee

The Executive Committee will comprise:

- the President of the Division (to Chair)
- the President-elect of the Division
- two elected members of the Council, as determined by the Council
- the Chair or permanent delegate of the Adult Medicine Division Education Committee
- one Adult Medicine Division Council trainee representative and alternate as determined by the Council
- the Chair or permanent delegate of the Aotearoa New Zealand Adult Medicine Division Committee.

#### 7. MEETING

This section is to be read in conjunction with the Governance of College Bodies By-law.

## 7.1. Number of Meetings

The Council shall hold a minimum of two meetings per calendar year and shall meet by teleconference, face to face, or videoconference.

## 7.2. Chair

The Chair or their appointee will Chair all meetings.

## 7.3. Quorum

A quorum is one half of the total Council membership.

## 7.4. Voting

Decisions will be made by consensus of the majority of members.

## 7.5. Minutes

The proceedings of all meetings of the Council shall be recorded in the minutes.

## 7.6. Secretariat

Meeting agenda, supporting papers and minutes or outcomes will be provided prior to the date of the meeting.

## 7.7. Council Reviews

The Council is to undertake a skill and experience review annually.

The Council is to review its performance against this By-law every two years.

## 8. REPORTING

The Council must report and make recommendations to the Board as required.

The Council is required to provide to the Board each year:

- a new or updated work plan (work plans may be one or two years)
- a report against the preceding years' work plan.

## 9. REVIEW OF BY-LAW

This By-law will be reviewed every three years.

Parent Body	Has the same meaning as in the Governance of College Bodies Bylaw.
Trainee	Has the same meaning as in the College Constitution.
