1. INTRODUCTION

These Terms of Reference are to be read in conjunction with the <u>Governance of College Bodies By-law</u>. Both the Governance of College Bodies By-law and these Terms of Reference govern the College Body.

1.1. Established

The Australasian Faculty of Public Health Medicine (AFPHM) Policy and Advocacy Committee is established under the authority of the AFPHM Council to perform the Functions set out in these Terms of Reference and all matters ancillary to those functions.

2. PURPOSE

The purpose of Australasian Faculty of Public Health Medicine (AFPHM) Policy and Advocacy Committee is to advocate across the Faculty and College, health professions, Government, business and the broader community involving policies and practices that optimise the health and wellbeing of the population.

3. FUNCTIONS

The functions of the Australasian Faculty of Public Health Medicine (AFPHM) Policy and Advocacy Committee are to:

- a) promote the principles of public health medicine;
- b) act as the authoritative source of direction and advice within the College in regards to public health medicine policy and advocacy;
- c) implement and monitor the policy and advocacy projects approved by the AFPHM Council;
- d) respond to new and emerging policy and advocacy issues relevant to the AFPHM as they arise in consultation with the AFPHM President, AFPHM Council, and College Policy and Advocacy Council prior to work commencing;
- e) contribute to the policy and advocacy issues in public health medicine to the College Policy and Advocacy Council;
- f) support the scheduled review of policy position papers; and
- g) support regional branches of the Faculty and Aotearoa New Zealand in providing local advocacy for public health medicine in their local health systems.

4. MEMBER COMPOSITION

The AFPHM Policy & Advocacy Committee Chair is usually the AFPHM President-elect, or otherwise nominated from within the AFPHM Policy & Advocacy Committee membership. The AFPHM Policy & Advocacy Committee Chair shall be a representative on the AFPHM Council.

The Membership of the College Body shall comprise up to 10 members, comprising:

4.1. Ex-officio Members

AFPHM President-elect

4.2. Appointed Members

- up to seven AFPHM Fellows; and
- up to two AFPHM trainees.

4.3. Co-opted members

Co-opted members may be appointed for a particular purpose or term.

5. MEETING

This section is to be read in conjunction with the Governance of College Bodies By-law.

5.1. Number of Meetings

The College Body may hold four meetings per calendar year and shall meet face to face (maximum once per year) or by videoconference.

5.2. Chair

The Chair or their appointee will Chair all meetings.

5.3. Quorum

A quorum is one half of the total College Body membership.

5.4. Voting

Decisions will be made by consensus of the majority of members.

5.5. Secretariat

Meeting agenda, supporting papers and minutes or outcomes will be provided prior to the date of the meeting.

6. REPORTING

The AFPHM Policy & Advocacy Committee must report and make recommendations to the AFPHM Council as required.

The AFPHM Policy & Advocacy Committee is required to provide to the AFPHM Council each year:

- a new or updated work plan (work plans may be one or two years); and
- a report against the preceding years' work plan.
