1. INTRODUCTION

The Board of the Royal Australasian College of Physicians has established the College Council. The Governance of College Bodies By-law sets out the general provisions for governance of Board Committees. Both the Governance of College Bodies By-law and this By-law govern the Committee.

2. PURPOSE

The purpose of the College Council is to act as the peak advisory body to the Board on strategic and cross-College issues.

3. FUNCTIONS

The functions of the College Council include to:

- consider matters referred to it by the Board or that the Council considers may be relevant to the Board, and if agreed by a majority of Council members, to make recommendations to the Board on the issues raised by those matters.
- raise matters considered by Council members considered relevant to the functioning, performance or goals of the College and report on these to the Board.
- c) provide representation from a wide cross-section of college Members to the Board so that concerns and suggestions can be aired in a suitable forum.
- d) consider matters for decision and approval from the College Sub-Committees or other College Bodies (of the Board's choosing) as delegated by the Board and provide appropriate reports and recommendations to the Board arising out of the business of those College Sub Committees or other College Bodies.
- e) approve the appointment of members to College Sub Committees or other College Bodies (of the Board's choosing) as delegated by the Board.

4. COMMITTEE PROHIBITIONS

The Committee must not:

- · Enter into any agreement binding upon it or on the College; or
- Represent or imply in any way that the Committee is a body independent of the College.

5. MEMBER COMPOSITION

The Membership of the Committee shall comprise up to 47 members, comprising:

5.1. Ex-officio Members

• the Chair of the College Education Committee or an approved delegate.

5.2. Appointed Members

Up to 45 appointed members comprising:

- a Fellow nominated by the Aotearoa New Zealand Committee (which may or not be the President-elect);
- a Fellow from each of the education pathways set out in Schedule 1 as nominated by their respective bodies;
- a Fellow nominated by the Adult Medicine Division Council;
- a Fellow nominated by the Paediatrics and Child Health Division Council;
- a Fellow nominated by the Australasian Faculty of Occupational and Environmental Medicine Council;
- a Fellow nominated by the Australasian Faculty of Public Health Medicine Council;
- a Fellow nominated by the Australasian Faculty of Rehabilitation Medicine Council;
- up to four (4) trainees nominated by the College Trainees' Committee;
- a Fellow nominated by each of the seven State and Territory Committees; and
- A Māori representative and an Aboriginal or Torres Strait Islander representative, who may be Fellows, trainees, or non-Members of the RACP.

5.3. Independent Community Members

Up to one independent community members comprising:

 a consumer representative from the RACP-appointed Consumer Advisory Group or an approved delegate.

5.4. Co-opted members

Co-opted members may be appointed for a particular purpose or term.

6. EXECUTIVE COMMITTEE

6.1. Establishment of Executive Committee

Subject to College Board approval, the College Council may but is not required to, establish an Executive Committee.

6.2. Membership of Executive Committee

The Executive Committee will comprise:

- the Chair and Deputy Chair(s) of the College Council; and
- other members of the College Council as determined by the College Council.

The Chair and Deputy Chair must be a current Member of the College, as endorsed by College Council.

6.3. Role of the Executive Committee

The Executive Committee shall meet in the intervening periods between College Council meetings and as otherwise required by the College Council, to exercise such powers of the College Council in managing the business and the interests of the College Council, as may be delegated to it by resolution of the College Council or as the Chair, in certain cases may decide.

7. BOARD ATTENDANCE AT COLLEGE COUNCIL MEETINGS

Members of the College's Board may attend meetings of the College Council as observers and will be available to take questions from College Council members and make any other comments on issues being discussed by the College Council if so requested by the College Council. Board members may not be appointed as a member of the College Council.

8. SUB-COMMITTEES

The College Council may, subject to College Board approval, create such other committees or time-limited or specific purpose working groups as the College Council may determine from time to time.

9. MEETING

This section is to be read in conjunction with the Governance of College Bodies By-law.

9.1. Number of Meetings

The College Council shall hold a minimum of three meetings per calendar year and shall meet by teleconference, face to face or videoconference.

9.2. Chair

The Chair or their appointee will Chair all meetings.

9.3. Quorum

A quorum is one half of the total College Council membership.

9.4. Voting

Decisions will be made by consensus of the majority of members.

9.5. Minutes

The proceedings of all meetings of the College Council shall be recorded in the minutes.

9.6. Secretariat

Meeting agenda, supporting papers and minutes or outcomes will be provided prior to the date of the meeting.

9.7. Council Reviews

The College Council is to undertake a skill and experience review annually.

Revision: 8.0

The College Council is to review its performance against this By-law every two years.

10. REPORTING

The Committee must report and make recommendations to the Board as required.

The Committee is required to provide to the Board each year:

- a new or updated work plan (work plans may be one or two years)
- a report against the preceding year's work plan.

11. REVIEW OF BY-LAW

This By-law will be reviewed every three years.
