1. INTRODUCTION

The Board of the Royal Australasian College of Physicians has established the Fellowship Committee (the "Committee"). The Governance of College Bodies By-law sets out the general provisions for governance of Board Committees. Both the Governance of College Bodies By-law and this By-law govern the Committee.

2. PURPOSE

The purpose of this Committee is to work closely with all College bodies, including the Divisions, Faculties and Chapters, to increase the value and relevance of membership for members.

3. FUNCTIONS

The functions of the Fellowship Committee include:

- a) Review and make recommendations regarding Member Services, including:
 - i. the development of a suite of member services;
 - ii. processes for supporting the pastoral care needs of members;
 - iii. recommend policies, review plans and provide advice in relation to the various vehicles used for communication with Members including College wide publications;
 - iv. Member engagement surveys as and when required and actions arising;
 - v. monitor a set of metrics (which may include a metric in relation to complaints made by Members) to assess the engagement of Members and their satisfaction with College services and activities to improve measures where required;
- b) Review and make recommendations regarding the following Member Initiatives:
 - i. the work of the College Library;
 - arrangements for the Annual College Congress and, at the direction of the Board, any other similar College wide events or programs not currently managed by another College body;
 - iii. College wide celebrations and events (such as anniversary celebrations):
 - iv. the annual admission to College Ceremony and any other such events; and
 - v. an awards framework and other forms of recognition and the naming of College spaces in line with the objectives of the College Constitution;
- c) Recognition of non-Fellows contributing to the College:

- i. make recommendations to the Board in relation to the awarding of Honorary Fellowships, other than recommendations made by Divisions, Faculties or Chapters; and
- recommend to the Board names of non-Fellows who should be considered ii. to receive a College award.
- Re-admission to Fellowship
 - make decisions on applications for re-admission to Fellowship. i.

4. **COMMITTEE PROHIBITIONS**

The Committee must not:

- Enter into any agreement binding upon it or on the College; or
- Represent or imply in any way that the Committee is a body independent of the College.

5. MEMBER COMPOSITION

The Membership of the Committee shall comprise up to 10 members, comprising:

5.1. **Ex-officio Members**

- the Chair of the College Trainees Committee (or other nominee of the Committee); and
- Congress Lead Fellow.

5.2. **Appointed Members**

Up to eight appointed members comprising:

- a Fellow nominated by the Adult Medicine Division Council;
- a Fellow nominated by the Paediatrics & Child Heath Division Council;
- a Fellow nominated by the Aotearoa New Zealand Committee;
- a Fellow nominated by the Australasian Faculty of Rehabilitation Medicine Council;
- a Fellow nominated by the Australasian Faculty of Occupational & Environmental Medicine Council;
- a Fellow nominated by the Australasian Faculty of Public Health Medicine Council: and
- two Fellows nominated by two different specialty societies.

5.3. Chair

On the recommendation of the Committee, the College Board will appoint a member of the Committee to act as the Chair.

5.4. Co-opted members

Co-opted members may be appointed for a particular purpose or term.

6. MEETING

This section is to be read in conjunction with the Governance of College Bodies By-law.

6.1. Number of Meetings

The College Body shall hold a minimum of four meetings per calendar year and shall meet by teleconference, face to face or videoconference.

6.2. Chair

The Chair or their appointee will Chair all meetings.

6.3. Quorum

A quorum is one half of the total College Body membership.

6.4. Voting

Decisions will be made by consensus of the majority of members.

6.5. Minutes

The proceedings of all meetings of the Committee shall be recorded in the minutes.

6.6. Secretariat

Meeting agenda, supporting papers and minutes or outcomes will be provided prior to the date of the meeting.

6.7. Committee/Council Reviews

The Committee is to undertake a skill and experience review annually.

The Committee is to review their performance against this By-law every two years.

7. EXECUTIVE COMMITTEE

7.1. Establishment of Executive Committee

Subject to College Board approval, the Committee may, but is not required to, establish an Executive Committee.

7.2. Membership of Executive Committee

The Executive Committee will comprise:

- a) the Chair of the Committee; and
- b) two other members of the Committee as determined by the Committee.

7.3. **Role of Executive Committee**

The Executive Committee shall meet in the intervening periods between the Committee meetings and as otherwise required by the Committee, to exercise such powers of the Committee in managing the business and the interests of the Committee, as may be delegated to it by resolution of the Committee or as the Chair, in cases of emergency may decide.

8. **SUB-COMMITTEES**

The Committee may, subject to College Board approval, create such other committees or time-limited or specific purpose working groups as the Committee may determine from time to time.

8.1 **College Bodies of the Fellowship Committee**

- Library Collections and Cultural Heritage Committee (LCCHC)
- Congress Program Committee (CPC)
- Gender Equity, Diversity, and Inclusion in Medicine Advisory Committee (GEDIMAC)

9. REPORTING

The Committee must report and make recommendations to the Board as required.

The Committee is required to provide to the Board each year:

- a new or updated work plan (work plans may be one or two years)
- a report against the preceding year's work plan.

10. **REVIEW OF BY-LAW**

This By-law will be reviewed every three years.
