The following communiqué highlights the key issues of the Paediatrics & Child Health Division Policy & Advocacy Committee (PPAC) for the first half of 2017.

#### **Position Statements**

Improving the health of children and young people is a priority for the Paediatrics & Child Health Division of the RACP. To achieve this, the PPAC continues to update published position statements as well as develop new position statements.

Position statements currently under development:

- Inequities in Child Health, led by Associate Professor Susan Woolfenden and Professor Sharon Goldfeld.
- Early Childhood, led by Dr Patrick Tuohy.
- Indigenous Child Health, led by Dr Danny de Lore.
- The PPAC are also scheduled to commence work on a number of previously published position statements which require minor updates.
- Paediatricians also continue to make valuable contributions to whole of College work.

#### Advocacy

• The PCHD Council and the PPAC have resolved to support an advocacy campaign on inequities in child health. The campaign will include the upcoming publication of the Inequities in Health Position Statement.
