Looking back to the start of my Presidency I recall the three focus areas I put forward;

- 1. Education and Training program
- 2. Finding out what it is that the Fellows require from our Faculty and College to support them in their practice
- 3. To continue to progress the current collaborations and projects.

I am pleased to report that all of the above are part of the AFOEM Council's strategic work plan 2019-2020.

Education

On behalf of the Faculty, I extend thanks to the Chair of the Education Committee Dr Alison Drewry and her team.

On 30 April 2019 I participated in a meeting attended by the Faculty Presidents and Chairs of the Education Committees of Occupational and Environmental Medicine, Public Health and

Rehabilitation Medicine to discuss the Advanced Training Curricula Review that is to occur over the next 2 years. This was an opportunity for the respective Faculties to highlight the uniqueness of each of their training programs and to have input into the development of faculty relevant program specific content. Follow-up meetings are planned as the review continues.

MyCPD

Dr David Fitzgerald has been nominated by Council as the AFOEM Lead Fellow to liaise on behalf of the Faculty with Michael Pooley, Senior Project Officer, Learning Support Unit, from the CPD unit. David will assist the CPD unit to identify activities and develop resources to assist AFOEM Fellows meet their Category 2 (review of performance) and Category 3 (measurement of outcomes) CPD requirements, particularly for those in non-clinical roles. Progress on the AFOEM Council's Strategic Work Plan is underway to improve the visibility and availability of research resources on the RACP website and to emphasize research as a cornerstone and foundation of OEM practices through education and publication of OEM research articles, opportunities and grants.

Collaboration and increased communication between Division, Faculties and Chapters

On Tuesday, 16 January 2019 I had the pleasure of participating in a teleconference with the Presidents of Adult Medicine Australia and NZ, Paediatrics, Public Health, and Rehabilitation Medicine. The purpose of the meeting was to discuss our respective workplans with a view to identifying commonalities where we can work together, rather than in isolation.

Some of the areas identified were communication, physician health and wellbeing, education, curricula review, research support and resources.

The discussion highlighted what is happening in other areas of the College and what their priorities are. It was also an opportunity to connect Presidents together particularly important since the devolution of the College Board from a representational Board to a skills-based Board. One outcome of the meeting is that the respective workplans will be reviewed with regard to the strategic goals of each group to ensure consistency in their alignment, with those of the Board. The workplans will be shared across participating Councils and Committees.

The aim is for the group to meet quarterly. Advice will be sought from governance on how to formalise this as a forum for discussion and a means of reporting to College Council.

This is an exciting development and in line with the AFOEM Workplan to improve communication and collaboration with other College bodies.

More effective communication to be enabled between AFOEM members is subject to whole of College infrastructure review and IT upgrade.

Information from the Membership Survey will be utilised as a starting point to gain an understanding of the 'needs and wants' of AFOEM members. The results of the survey will be brought to the next Council meeting.

Policy and Advocacy

The Policy and Advocacy Committee has had some exceptionally busy 12 months. On behalf of our Faculty I thank the Faculty Policy and Advocacy Committee members ably led by the Chair Dr Warren Harrex, for their hard work and commitment. As an overview;

<u>Accelerated Silicosis</u>

Dr Graeme Edwards has been pivotal in identifying the presence and magnitude of this preventable and at present untreatable condition in Queensland in September 2018. Since then he has worked tirelessly with the Policy and Advocacy Committee, collaborating with other specialty societies, respiratory physicians and radiologists, to address the devastating and fatal outcomes associated with this disease. He has helped to develop policy statements, to lobby state and federal governments and insurers, and had input into calls for the establishment of a national occupational respiratory disease registry and the development of clinical guidelines for the identification and management of the condition.

A joint AFOEM/TSANZ proposal for a National Registry for Occupational Lung Diseases was presented to the Clinical Principal Committee (CPC) in February 2019. The CPC provides strategic advice to the Australian Health Minister's Advisory Council (AHMAC) on issues of national significance that require technical clinical expertise.

AFOEM has contributed to the RACP NSW State Election Statement on Accelerated Silicosis. RACP has identified this as one key priority and are calling for whichever party takes government to implement, 1) the immediate health screening and surveillance of workers and stonemasons working with artificial stone, 2) to review workplace controls and exposure to dust levels, and 3) to collaborate with the Federal and other state and territory governments on this national issue.

Queensland, NSW, Victoria, South Australia and Western Australia are addressing accelerated silicosis to varying degrees.

In November 2018 as President of AFOEM I sent out a letter to all State and Territory relevant Ministers and Heads of Regulatory Authority seeking their support for urgent health assessment and monitoring of all potentially exposed workers, to enable early identification and optimal management of those found to have accelerated silicosis and the implementation of effective prevention strategies. I received responses from Queensland, ACT, WA, SA. AFOEM has endorsed and added its support to an application from TSANZ for an NHMRC grant to conduct research into obtaining a better understanding of the artificial stone silicosis epidemic in Australia, how it can be prevented and treated.

In March 2019 letters from the Presidents of RACP (Prof Mark Lane), AFOEM (Dr Beata Byok), and TSANZ (Prof Allan Glanville) were sent to relevant Commonwealth Ministers and Shadow Ministers and to all State and Territory Ministers for Health and Industrial Relations asking them to establish a Dust Diseases Taskforce. The letter called for a national coordinated response and outlined the proposed terms of reference to address the current epidemic of accelerated silicosis.

On April 30, 2019 prior to the Australian Federal Election there was a joint media release from RACP, AFOEM, Thoracic Society of Australia and New Zealand, The Australian Institute of

Occupational Hygienists, the Australian New Zealand Society of Occupational Medicine and the Lung Foundation, calling on both major parties in the upcoming election to commit to the formation of a national task force and fund a national occupationally acquired respiratory disease surveillance and registry program to address the public health crisis facing the artificial stone benchtop industry. On the same day, the Federal Health Minister the Hon. Greg Hunt, pledged \$5 million to establish a national dust disease taskforce. On May 1, 2019, the following day, the Victorian Premier announced measures to address the dry cutting of any material containing crystalline silica, free health screening for Victoria's 1400 stonemasons, a new compliance code for businesses working with silica and the introduction of an awareness campaign highlighting the risks of working with engineered stone.

Submission to the Australian Parliamentary Inquiry into the management of per-and polyfluoroalkyl substance (PFAS) contamination in and around Defence Bases. College submission to a Parliamentary inquiry into Biotoxin-related illness in Australia was released in October 2018. Dr Graeme Edwards represented the RACP before a parliamentary committee.

College submission to the Productivity Commission report into Compensation and Rehabilitation for current and ex-ADF members.

Queensland Inquiry into the Health and other Legislation Amendment Bill 2018 Responding to Queensland Government Department of Natural Resources, Mines and Energy

Request for AFOEM feedback on the proposed expert Medical Advisory Panel aligned with the recommendation of the coal mine dust lung disease (CMDLD) Collaborative Group.

Employment Poverty and Health (EPH)

The Employment Poverty and Health Statement of Principles was approved by AFOEM Council and will be launched in Auckland at Congress. This was a collaborative College activity led by AFOEM, which was represented by Dr David Beaumont (Reference Group Chair), Assoc/Prof. Peter Connaughton and Dr Robin Chase, together with Dr Bret Hart and Dr Farhan Shazad. The statement of principles will be launched at Congress tomorrow.

Health Benefits of Good Work (HBGW)

Continue to support the work of the HBGW campaign and explore additional resourcing. Proposed evaluation of the HBGW impact on organisations and society by gathering qualitative and quantitative data through a survey to current signatories.

AFOEM - ANZSOM Collaboration

The inclusion of an ANZSOM representative on AFOEM Council this year, Dr Miguel Kabilio, who is also a Fellow of the Faculty, ushers in a period of increased collaboration between the two bodies.

The collaborative ANZSOM/AFOEM Annual Scientific Meeting will be held in Adelaide from

27-30 October 2019, with equal input from each body into the scientific program. ANZSOM will hold the financial risk for the ASM.

Dr Josh Munn is the AFOEM representative on a committee that has significant dual representation from ANZSOM members who are also AFOEM fellows.

The Theme is Making it Work: Practical solutions in Occupational Health.

Council has also agreed to collaborate on the next ANZSOM conference to be held in Launceston Tasmania 19-22 March 2020. An EOI will be going out for an AFOEM representative to be on the organising committee. The conference is being held earlier in the year because of ANZSOM's involvement as the host body for ICOH 2021 in Melbourne.

ANZSOM has approved the inclusion of an AFOEM Trainee representative in the executive of each ANZSOM Branch and on Federal Council.

A/Prof Peter Connaughton immediate past-president of AFOEM signed a Model of Collaboration with Dr John Heydon ANZSOM (New Zealand) President in May 2018.

Regional Update - Tasmania

In the August 2018 eBulletin there was an article 'Occupational Physicians needed 'Down-Down Under' by Dr Peter Sharman, about the impending crisis due to a potential lack of OEP physicians in Tasmania, as 80% of the OEP's move towards retirement. In response to this crisis and at the invitation of the local members I travelled to Hobart in April and together with Dr Peter Sharman and Dr Helen McArdle attended a full day of meetings, with several organisations, including employers, insurers, unions, AMA, RACGP and the Hon. Sarah Courtney MP, Minister for Building and Construction.

The purpose of the visit was a fact-finding exercise, to support the local fellows and current trainees and an opportunity to fly the flag and raise the profile of occupational physicians; explaining what we do, how our input is essential in achieving and maintaining workplace health and how our expertise is applicable in a wider community context, for example with the NDIS.

I received a positive response from those organisations that we have traditionally worked closely with, general practitioners, insurers, employers and unions. Opportunities and potential strategies were discussed, but more work will need to occur. I asked the Hon. Sarah Courtney to work collaboratively with AFOEM and other key stakeholders to develop a strategy for maintaining and growing a local OEP workforce in Tasmania.
