The tables provide examples of activity types and acceptable evidence that may be used to demonstrate participation.

CPD category	When to use this category	Examples
Educational Activities (EA)	When you are learning new knowledge or skills	Conferences, courses, journal clubs, teaching
Reviewing Performance (RP)	When you are reviewing or receiving feedback on your professional practice	PDP, Annual Conversation, peer review, mentoring
Measuring Outcomes (MO)	When you are reviewing data or evaluating outcomes	Clinical audit, mortality & morbidity review, research analysis
