REMINDERS

Children aged 5-11 now eligible for second dose of COVID-19 vaccine

Many children are now eligible for their second dose of their primary course of COVID-19 vaccine. Practices are encouraged to proactively reach out to parents and carers of children who have received their first dose of the vaccine and are now due for their second dose. Please consider making appointments available outside school hours or additional clinics on the weekend or through the school holidays.

Opportunistic vaccination

Please continue to utilise the opportunity to conduct whole-family vaccination appointments where available such as booking in adults for their boosters along with their children for their COVID-19 vaccine. Where possible, we would encourage practices to directly reach out to patients not already booked in to support this booking as soon as possible.

Co-claiming can be used for these appointments, please refer to the <u>factsheet</u> for further information. Practices are encouraged to proactively reach out to any patients that you know have received their second dose of a COVID-19 vaccine but not their booster to make a booking.

Vaccine withdrawals

To assist with accurate recording of sites wanting to withdraw from administering selected vaccines, we ask that you contact your PHN to notify your intention to withdraw or amend the vaccines you will be administering. Your PHN will pass this information onto the Taskforce to enable the accurate administration of the request.
