Highlights

- **First Nations:** Dr Kimberley Male, appointed Chair of the Aboriginal and Torres Strait Islander Health Committee.
- **Pre-Federal Budget submission:** The RACP's <u>pre-budget advocacy covered a range of key</u> workforce, access to care, health reform and preventative health issues.
- Telehealth advocacy: Dr Jacquline Small, former President, spoke to <u>radio outlets</u> advocating for the reinstatement of a full suite of telehealth MBS items following the RACP's <u>media release</u>. The Hon Kirsty McBain, Minister for Regional Development, acknowledged the relevance of the College's telehealth advocacy to regional patients.
- **Climate Change:** The RACP released a climate-focussed pre-budget <u>media release</u>, which received significant media coverage including an ABC breakfast interview.
- Adolescent and Young Adult Medicine: Two successful meetings held for the RACP's *first* Youth Advisory Group, which has been established to support the development of the new RACP position statement on Youth Appropriate Health Care.
- **Medication shortages:** The RACP provided a <u>submission</u> to a key TGA consultation on the management of medicine shortages in Australia.
- **Tasmanian election statement**: The Tasmanian Committee developed an <u>election statement</u> calling on political leaders in Tasmania to commit to a range of priorities. The RACP reached out to all 3 political parties, all of whom affirmed our asks.
- **Silicosis:** widespread media coverage following the publication of the RACP <u>media release</u> calling on the New Zealand Government to follow Australia's lead to ban engineered stone and support workers already exposed to silica dust.
- EVOLVE: The RACP attended the Thoracic Society of Australia and New Zealand and the Australian and New Zealand Society of Respiratory Science (TSANZSRS) Annual Scientific Meeting to promote the Thoracic Society of Australia and New Zealand (TSANZ) Evolve low-value care recommendations.

Advocacy campaign updates



The RACP has long advocated for national regulations to reduce junk food advertising to children on all media through our <u>Switch off the Junk</u> campaign. Our leadership was recognised by the Commonwealth Department of Health and Aged Care through our participation in design workshops for a regulatory system attended by PCHD President, Professor Nitin Kapur. The College since followed up with a <u>submission</u> to the Department on the detailed design of an effective regulatory system that promotes the health and wellbeing of children from the earliest point in life.



The RACP sent renewed invitations to 29 specialty societies and the Australasian College of Sport and Exercise Physicians to endorse the <u>Healthy Climate Future Campaign</u>. The Campaign is currently supported by 13 medical colleges and 11 specialty societies.

CPAC Plan Focus Areas

1 First Nations Health and Equity

Aboriginal and Torres Strait Islander Health Committee

- The first ATSIHC meeting of the year recommended to the Board the appointment of Dr Kimberley Male as Chair and welcomed 2 new members - Dr Elkie Hull, Pediatrician and Dr Scott Jones, Nephrologist. The ATSIHC 2024 Workplan was considered and will go to the Board for approval.
- Reconciliation Australia has conditionally approved the RACP Innovate Reconciliation Action Plan (RAP). We aim to launch the new RAP in May during Reconciliation Week.

Indigenous Strategic Framework

• Mid-term Indigenous Strategic Framework review planning has commenced.

Youth Justice / Raise the Age

- The SA Government is proposing to <u>raise the minimum age of criminal responsibility (MACR)</u> from 10 years to 12 years of age.
- The RACP made a <u>submission</u> to the Queensland Youth Justice Inquiry, covering the RACP's advocacy to raise the MACR to 14 years, the need for comprehensive health assessment and

supports, and the importance of First Nations leadership in system reform and healthcare delivery.

2 Health reform

- The RACP 2024 <u>Pre-Budget Submission</u> to the Australian Government Treasury promoted via <u>media release</u> and social media.
- Ongoing advocacy on telehealth as part of the College's Pre-Budget push recognised by the Minister for Regional Development, Kirsty McBain on ABC radio.
- <u>Submission to Department of Health and Aged Care Feasibility Study on options to limit junk food</u> <u>advertising to children.</u> This identified necessary components of a national regulatory system to reduce the harmful exposure of children to junk food advertising in all its forms.
- <u>Submission to the TGA on the challenges and opportunities of medicines shortages in Australia.</u> This identifies key issues for specialists and their patients when a medicine shortage occurs, impacts for clinical care, practitioner workload and wellbeing. It proposes reforms to TGA processes for predicting, identifying, assessing and communicating shortages and strategies to attract and retain international supplies as well as strengthen local markets.
- Briefing to Dr Kerry Chant PSM, NSW CHO, on innovative models of secondary prevention and care involving specialists in community settings to support her engagement with the NSW Special Commission of Inquiry into healthcare funding.
- Advice to the TGA on the removal of glucagon-like-peptide-1 receptor agonist analogues from the pharmacist extemporaneous compounding exemption. This offered broad support for the amendment and provided feedback on potential unintended consequences.
- The RACP attended the TSANZSRS ASM exhibition to promote TSANZ Evolve low-value care recommendations.
- Planning a CSIRO/College antimicrobial resistance campaign promoting Evolve.
- Wide-ranging social media campaign in the lead up to World Obesity Day.

3 Climate

- The RACP provided <u>advice to the Australian Federal Treasury</u> emphasising the need to quantify the costs of climate change on health and the economic benefits of taking action to inform climate health policy.
- We released a climate-focussed pre-budget <u>media release</u>, which received significant media coverage including an ABC breakfast interview.
- The RACP endorsed a joint article on climate change and health with the Royal College of Physicians London and the Royal College of Physicians and Surgeons of Cananda. It is currently being pitched for publication in an academic journal.

- The Climate Change and Health Working Group met in March and discussed the release of Australia's National Health and Climate Strategy, the Australian National Adaptation Plan consultation, and the planned position statement on health and fossil fuels.
- P&A continues to meet with the Commonwealth Department of Health and Aged Care to discuss progress on the Implementation of the National Health and Climate Strategy.
- The RACP held a multi-college consultation on anaesthetic and other gases, at the request of the Commonwealth Department of Health and Aged Care. Twenty-seven members from across ten medical colleges attended, including four RACP members.
- The RACP attended Asthma Australia's second inhaler roundtable, focusing on reducing emissions from respiratory inhalers and transitioning to quality, low-carbon asthma care.
- The RACP participated in the Macquarie University Australian Institute of Health Innovation Research Roundtable, addressing the impact of climate change on human health and bridging research and action for a sustainable future.

4 Populations in Focus

Paediatrics and Child Health

RACP submission to the <u>NSW Inquiry into improving access to early childhood health and development checks</u> outlines five key recommendations responding to the Inquiries <u>Terms of Reference</u>. The recommendations include prioritising investment in Aboriginal and Torres Strait Islander health leadership, the expansion of models of care which support children in rural and remote communities to access health services, the importance of multidisciplinary teams for child assessments and initiatives that support access to quality early childhood education programs for all three-year-olds. Further activity on the Inquiry has been deferred pending completion of another Inquiry being led by the Committee.

Adolescent and Young Adult Medicine

 Two meetings of the RACP's *first* Youth Advisory Group were held during January and March. The Youth Advisory Group was established in late 2023 to support the development of the new RACP position statement on Youth Appropriate Health Care. We are privileged to have twelve young people participating in this important policy work.

Disability

 The RACP provided a <u>submission</u> to the Department of Social Services regarding the Disability Royal Commission's final report. This focused on ensuring a greater focus on healthcare issues in the Government's response to the Royal Commission. A table detailing the inclusion of a significant number of RACP recommendations in the Royal Commission's final report can be found <u>here</u>. The final report of the Government's NDIS Review, Working Together to Deliver the NDIS echoed many of the recommendations by the RACP over the past four years. Addiction medicine

- <u>Consultation</u> with relevant committees, affiliated societies and members on the draft Drug Policy Position Statement developed by the joint AChAM/AFPHM Drug Policy Working Group
- Advocacy in support of the recently implemented NSW drug diversion scheme via a media release.

COVID-19

 In February, the Australian Government published its <u>response</u> to the House Standing Committee on Health, Aged Care and Sport Report's <u>final report</u> on the <u>Inquiry into Long COVID and</u> <u>Repeated COVID Infections</u>, (published in April 2023.) Overall, the Australian Government was supportive of the report recommendations, which aligned strongly with the RACP's recommendations in its <u>inquiry submission</u>.

Health care of workers

• The Improving the Health of Healthcare Workers (IHHCW) working group held its third meeting in March and has advanced its development of the new guidance policy document.

5 Aotearoa New Zealand

Silicosis

A RACP <u>media release</u> asking for urgent government action on silicosis was published. This
called for a ban on the use of engineered stone and an official Registry of people with workplace
silica dust exposure to allow long-term follow-up and support. Media follow-up also included
broad online and radio coverage.

Syphilis

 The RACP endorsed a letter from the New Zealand Sexual Health Society asking for government action to address the syphilis epidemic. The letter outlines the goal should be elimination of congenital syphilis, reduction of syphilis cases to below 2014 case numbers and elimination of the inequity in case numbers between Māori and other ethnicities. This letter was supported by the Māori Health Committee, AChSHM, Aotearoa Policy and Advocacy Committee and Aotearoa NZ Committee.

State and Territory Advocacy

Northern Territory

• <u>Submission</u> to the NT Government's consultation process for developing a framework for Voluntary Assisted Dying, aligning closely to the College's existing statements.

Western Australia

• Welcomed major expansion of Child Development Service, following submission to and evidence given at WA Parliamentary Inquiry.

NSW/ACT

Meeting with NSW Health Minister covering accreditation, workforce, and wellbeing. Follow-up
meetings were arranged with the Deputy Secretary for Regional Health focusing on regional,
rural and remote issues, with a further meeting planned in May with the District Director, Medical
Workforce, Ministry of Health focusing on workforce and education training.

Queensland

- Meeting with QLD Health Minister covering workforce and physician/trainee wellbeing
- RACP <u>submission</u> to QLD Parliament's Youth Justice Reform Inquiry, and <u>media</u> supporting.

Tasmania

- An early election was held in on Saturday 23 March 2024. The Tasmanian Committee developed an <u>election statement</u> calling on political leaders in Tasmania to commit to a range of priorities. These included supporting the specialist workforce to meet growing health care needs, fostering a culture of wellbeing for physicians and trainees, improving access to healthcare for priority populations including older people, people with disabilities, paediatric care in the community, universal quality early childhood education, and evidence-based school support for children.
- A media release was published with the statement also promoted on the Tasmanian ROC.
- The election statement received responses from all three major parties (the Liberal Government, the ALP, and the Greens), affirming our advocacy asks.


