## Key Changes

Key changes from previous subject weightings:

- Traumatic brain injury: upper limit reduced from 20% to 15%
- Spinal cord injury: upper limit reduced 20% to 15%
- Amputation of limb and prosthetics: range reduced from 20-40% to 5-10%
- Cardiac and respiratory conditions: range reduced from 10-20% to 5-10%
- Rehabilitation of older people: range reduced from 10-20% to 5-10%
- Pain: upper limit increased from 5% to 10%
- Orthotics and footwear: now explicitly assessed (2-5%)
- Spasticity and its management: now explicitly assessed (2-5%)
