#### 1. INTRODUCTION AND PURPOSE

The Advanced Training Committee in Gastroenterology has appointed members and delegated to a Sub Committee of the Advanced Training Committee in Gastroenterology, to be known as the **Curriculum Review Group for Gastroenterology**, responsibility for developing a new Advanced Training curriculum for gastroenterology in accordance with College frameworks, models and processes.

#### 2. ROLE AND RESPONSIBILITIES

- **2.1.** The role and responsibilities of the Curriculum Review Group for Gastroenterology are to:
  - **2.1.1.** evaluate the current state of the training program and make recommendations about how it can be improved
  - **2.1.2.** design and develop a draft new curriculum according to the RACP curriculum model, including curriculum standards and learning, teaching and assessment programs
  - **2.1.3.** plan a consultation on the new curriculum, including mapping relevant stakeholders
  - **2.1.4.** review the draft curriculum and make recommendations for changes in response to stakeholder feedback
  - **2.1.5.** draft a plan for implementing the new curriculum
- **2.2.** The Curriculum Review Group for Gastroenterology will operate in accordance with:
  - **2.2.1.** These Terms of Reference
  - **2.2.2.** The College's policies and procedures, including the *Conflicts of Interest* and *Code of Conduct* Policies.

#### 3. EXTENT OF AUTHORITY

The Curriculum Review Group for Gastroenterology is an advisory and recommending body only and does not have authority to:

- **3.1.** Enter into contractual relationships.
- **3.2.** Represent or imply in any way that the Curriculum Review Group for Gastroenterology is a body independent of the College.

#### 4. MEMBERSHIP

- **4.1.** The Curriculum Review Group for Gastroenterology shall comprise of a maximum of 12 individuals who are members of the RACP.
- **4.2.** The membership will include the following roles, noting that any one member may perform multiple roles:
  - **4.2.1.** A Chair
  - **4.2.2.** A Deputy Chair, appointed by the Chair
  - **4.2.3.** At least one member representing adult gastroenterology
  - **4.2.4.** At least one member representing paediatric gastroenterology
  - **4.2.5.** At least one member who is a member of the specialty society
  - **4.2.6.** At least one member who is based in Aotearoa New Zealand
  - **4.2.7.** At least two members who are trainees at the time of appointment to the Group
  - **4.2.8.** At least one member who has completed Advanced Training in the specialty within the last five years at the time of appointment to the Group
- **4.3.** The members of the Curriculum Review Group for Gastroenterology will be appointed by the Advanced Training Committee in Gastroenterology.
- **4.4.** The Chair of the Curriculum Review Group for Gastroenterology will be the Curriculum Lead(s) on the Advanced Training Committee in Gastroenterology.
- **4.5.** The Curriculum Review Group for Gastroenterology will be supported by the Advanced Training Curricula Renewal project team.

#### 5. DURATION

**5.1.** The term of membership shall be for a maximum term of two years or such shorter period as determined by the Advanced Training Committee in Gastroenterology.

#### 6. FREQUENCY AND LOCATION

**6.1.** The Curriculum Review Group for Gastroenterology will meet as frequently as determined by the Chair and the needs of the Advanced Training Curricula Renewal project, face-to-face or by videoconference.

#### 7. REPORTING

- **7.1.** The Curriculum Review Group for Gastroenterology will report to the Advanced Training Committee in Gastroenterology.
- **7.2.** The Curriculum Review Group for Gastroenterology will provide a written report to the Advanced Training Committee in Gastroenterology on progress against its objectives as required by the Advanced Training Committee in Gastroenterology.

### 8. DEFINITIONS

"Advanced Training Committee in Gastroenterology" means the Advanced Training Committee in Gastroenterology of The Royal Australasian College of Physicians

"College" means The Royal Australasian College of Physicians
